- Contract adjustment for Liz Koenig to include 10 additional contract day at a salary of \$2,694 based on current contract amount
- Open enrollment of Bridget McIntyre out of the MOC-Floyd Valley Community School District into the Connections Academy for the 2022-23 school year for the next three years
- Open enrollment of Sydney Sickelka into the MOC-Floyd Valley Community School District out of the South O'Brien Community School District for the 2022-23 school year for the next two years

An update was given on the new elementary building project and proposed high school addition.

Kristen Puttmann and Beth Oolman provided the board with a district literacy and language arts report.

Grant Hegstad shared information on the CAPS program.

Mark Gunderson gave an update on athletics in the district.

Motion by Koerselman, supported by Koerselman to approve the trademarking of the Dutchman logo at a cost of \$1,300. Motion carried unanimously.

A monthly progress report was given by the building principals.

Motion by Reyes, supported by Koerselman to approve the expansion of the transitional kindergarten program from half days to full days beginning with the 2023-2024 school year. Motion carried unanimously.

Motion was made by Koerselman, supported by Reyes and carried unanimously to approve the 300 series of Board Policies.

The board reviewed the Return-to-Learn plan.

The board was provided information on the upcoming IASB convention.

The first reading was presented of the board policies in the 600 series and 805.5.

Motion was made by De Jong and supported by Reyes to approve the LEP Excess Costs Application

which requests the modified allowable growth in the amount of \$54,697.80 for excess LEP expenditures from the 2021-22 school year. Motion carried unanimously.

Motion was made by De Jong, supported by Kleinhesselink to authorize the district's administration to submit a request to the School Budget Review Committee for a modified supplemental amount of \$36,135 due to an increase of open enrolled students out of the district in fall of 2022. Motion carried unanimously.

Motion was made by Reyes, supported by Kleinhesselink to authorize the district's administration to submit a request to the School Budget Review Committee for a modified supplemental amount of \$35,828.90 related to the English language learning program for students who have exceeded five years of weighting that are included on the fall 2022 certified enrollment headcount. Motion carried unanimously.

Motion by Kleinhesselink and supported by Reyes to approve the proposed Robotics Team Fundraiser of Krispy Kreme donuts. Motion carried unanimously.

Motion by Kleinhesselink and supported by Koerselman to approve the proposed FCCLA Fundraiser of sending out donation request letters and strawberry sales. Motion carried unanimously.
