The MOC-Floyd Valley Board of Education met on the above date at the Central Administration Office for its regular monthly meeting with all board members in attendance, except Kleinhesselink. Also present were Superintendent Adams, Secretary Dykstra, building principals and the press.

Motion by De Jong, supported by Reyes to approve the Resolution Directing the Sale of \$675,000 General Obligation Bonds, Series 2023. De Jong-aye, Jager-aye, Koerselman-aye, and Reyes-aye.

Motion by Koerselman, supported by De Jong to approve purchase of a used 12-passenger van from Mulder Oil for \$48,990. Motion carried unanimously.

Motion by Reyes and supported by De Jong to approve the Siouxland Conference contract with Bound to provide “Path to Cashless” Services to the schools in the conference. Motion carried unanimously.

Motion by De Jong, supported by Koerselman to approve the increase in varsity athletic ticket prices to \$8.00 for the 2023-2024 school year as long as it passes throughout the Siouxland Conference. Motion carried unanimously.

Motion by De Jong, supported by Koerselman and carried unanimously to approve the 700, 800, and 900 series of Board Policies.
