President Jager announced that this is the time, place and date to hold a hearing on the resolution to sell real estate locally known as Block 1 Skillman's Addition in Alton, Iowa, to the City of Alton for \$25,340. Superintendent Adams presented the resolution. Since there were no objectors, the president declared the hearing closed.

Joel Bundt and Dave Pfaffle provided the board with a district math and computer science report.

Grant Hegstad shared information on the CAPS program.

Mitch Aalbers gave an update on athletics in the district.

A monthly progress report was given by the building principals.

An update was given on the elementary building project and the high school addition.

Motion was made by Reyes, supported by Koerselman and carried unanimously to approve the following consent items:

Motion was made by Koerselman, supported by Reyes and carried unanimously to approve the 100 series of Board Policies.

The board reviewed the Return-to-Learn plan.

The board was provided information on the upcoming IASB convention.

Superintendent Adams shared a follow up of the SIAC meeting that was held last week.

The first reading was presented of board policies 401.1, 701.05R1, and the 500 series.

Motion by Koerselman, supported by Fernstrum to approve the sale of Block 1 Skillman's Addition to the City of Alton for \$25,340. Motion carried unanimously.

Motion was made by Fernstrum and supported by Reyes to cast the district ballot for Roger Brinkert to serve as the Northwest AEA Board of Directors for District 3. Motion carried unanimously.

Motion by Koerselman and supported by Fernstrum to approve the resolution to Maintain Confidentiality of Superintendent Application Materials During Superintendent Search per Iowa Code section 22.7(18). Motion carried unanimously.

Motion by Koerselman, supported by Reyes to approve the advertisement and hiring of a part-time director of maintenance and grounds. Motion carried unanimously.

Motion by Koerselman, supported by Reyes to clarify long-term substitute teacher pay and follow Board Policy 410.1 as written. Motion carried unanimously. Substitute teachers will be paid at the per diem rate of the BA base salary schedule after five consecutive days on a specific assignment.

The board took a tour of the high school addition.
