

MOC-FLOYD VALLEY COMMUNITY SCHOOL - - - - February 12, 2024

The MOC-Floyd Valley Board of Education met on the above date at the Central Administration Office for its regular monthly meeting with all board members in attendance. Also present were Superintendent Adams, Secretary Dykstra, building principals, and the press.

President Jager called the meeting to order at 4:58 p.m.

Motion was made by Koerselman and supported by Reyes to approve the agenda as mailed. Carried unanimously.

Sharon Foughty shared the vocal music team report to the board.

Chris Lang and Abby Vande Kieft provided the board with a district science report.

John Van Wyk, transportation director, presented the annual district transportation report.

Bids were received for the purchase of a new bus:

- Thomas - \$181,324 for a 260 hp motor and \$3,000 for front air suspension
- Blue Bird - \$176,056 for a 280 hp motor and includes front air suspension.

Motion by Kleinhesselink, supported by Reyes to approve the purchase of a new bus from Blue Bird for \$176,056 to be received in July of 2025. Motion carried unanimously.

A monthly progress report was given by the building principals. Principal Mulder presented the District Career Academic Plan.

An update was given on the health insurance renewal for the 2024-2025 fiscal year.

Superintendent Adams gave a legislative update.

Information was shared on the Director of the Iowa Department of Education, Mckenzie Snow's upcoming visit to the district.

Motion by Koerselman, supported by Kleinhesselink and carried unanimously to approve Board Policies 506.1-508.2.

The board reviewed the Return-to-Learn plan.

The first reading was made for Board Policies 600-603.11, 502.07, 605.06, 605.08, 701.01-701.01, 703.1, 703.2, and 713.

Motion by Fernstrum, supported by Koerselman to approve the Resolution Authorizing the Redemption of General Obligation School Bonds, Series 2023, Dated June 27, 2023, Approving an Escrow Agent Agreement, and Levying a Tax for Fiscal Year 2025 for the Redemption of General Obligation School Bonds, Series 2023, Dated June 27, 2023. Fernstrum-aye, Jager-aye, Kleinhesselink-aye, Koerselman-aye and Reyes-aye.
