Superintendent Adams gave the board a legislative update.

Motion was made by Kleinhesselink and supported by Koerselman to approve the PPEL/SAVE budget for the 2024-25 fiscal year. Motion carried unanimously.

Motion by Koerselman, supported by Reyes to approve the proposal from Phillips Floors to sand and refurbish the high school gym at a cost of \$49,175. Motion carried unanimously.

Motion by Fernstrum and approved by Kleinhesselink to approve the extension agreement by and among the City of Alton, Sioux County, and the MOC-Floyd Valley Community School District for a TIF valuation. Motion carried unanimously.

Superintendent Adams presented the preliminary budget for the 2024-25 fiscal year. State Supplemental Aid for next year has not been set so the budget is based off of the Governor's recommendation of 2.5%. The proposed tax levies are as follows:

The instructional support levy is based upon 10% of the regular program cost with a rate of 1% income surtax. The first public budget hearing will be held on March 26, at 7:00 a.m. The notice of proposed tax notice was published in the March 14 issue of the Sioux County Capital-Democrat. The second public hearing will be held on April 8, at 6:00 a.m. That second notice will be published in the March 28 issue of the Sioux County Capital-Democrat. Motion by Kleinhesselink, supported by Reyes to approve the preliminary budget for the 2024-25 fiscal year. Motion carried unanimously.

Motion was made by Reyes, supported by Kleinhesselink and carried unanimously to approve the following Budget Adjustment (Guarantee) Resolution:

RESOLVED, that the Board of Directors of MOC-Floyd Valley Community School District, will levy property tax for fiscal year 2024-2025 for the regular program budget adjustment as allowed under section 257.14, <u>Code of Iowa</u>.

At 6:58 a.m., motion by Kleinhesselink and supported by Koerselman to enter exempt session from the open meetings law for a negotiation strategy session. Roll call vote: Fernstrum—aye, Jager-aye, Kleinhesselink—aye, Koerselman—aye, and Reyes—aye.
