## MOC-FLOYD VALLEY COMMUNITY SCHOOL - - - October 12, 2015

The MOC-Floyd Valley Board of Education met on the above date at the Central Administration Office for its regular monthly meeting. All members of the board were present, except Immeker. Also in attendance were Superintendent Adams, Principal Smith, Secretary Dykstra and the press.

The meeting was called to order at 5:04 p.m. by President Van Roekel.

Motion was made by Koerselman and supported by Kleinhesselink to approve the agenda with the addition of reviewing conduct at athletic events and informing the board of a legislative change. Motion carried unanimously.
