

HEALTH INFORMATION FOR TK/KINDERGARTEN ENROLLMENT

WHAT IS REQUIRED BEFORE MY CHILD MAY START THE FIRST DAY OF TK/KINDERGARTEN?

(1.) IMMUNIZATION FORM - Iowa law requires these immunizations must have been given and the state record received by the school BEFORE the first day of kindergarten or TK:

- ⇒ Must have **DTap - 5 doses** and **Polio Vaccine - 4 doses**; *one of each* must have been given *on or after age 4*
- ⇒ Must have **MMR - 2 doses**; *1st dose after 12 months, 2nd— 28 days later at least*
- ⇒ Must have **Hepatitis B Series - 3 doses**
- ⇒ Must have **Varicella** (chicken pox) - **2 doses** OR approximate date of having had the disease.

A signed Certification of Immunization (GOLD example included), or Medical/Religious exemption must be on file before the first day of school. Please turn in this Certification to the office ASAP after TK/KG visit day.

(2.) HEALTH INFORMATION— If your child has a health concern that directly affects him/her at school, please fill out a red “**Health Information**” sheet at TK/KG Information night, or notify the office before visit day in April. *(includes but not limited to: allergies, diabetes, asthma, seizure, ADHD, Autism, Developmental Delays, other health diagnosis)*

The “**Health Questionnaire and Consent**” will be sent via Infinite Campus parent portal in August. Parents must fill this out for each student before the start of school. This is in addition to filling out the health information page above if your child has a health condition that affects him/her at school.

(3.) LEAD SCREENING—Iowa law requires a lead screen done once sometime before school entrance. This is usually done at 1 year physical. There is NO NEED to turn in proof, but Iowa law asks that you check with your doctor to make sure it is completed.

(4.) DENTAL SCREENING - A Dental screening is required by Iowa law for school entrance for TK and Kindergarteners. Any screening by your dentist after age 3 completes the requirement. Please have your dentist fill out the YELLOW screening form and turn into the office at registration or by November 1st, 2025 at the latest.

(5.) VISION SCREENING - A vision screening is required for KG entrance within 1 year of starting (any exam done after August 24th, 2024 will meet this requirement). This can be done at a local eye doctor or at your annual physical by your doctor. Please have BOTH sides of the green form filled out by the provider and turned in at registration or before November 1st, 2025 at the latest. *(not required for TK, but can be done during TK year for KG requirement)*

(6.) SCHOOL PHYSICAL— MOC-FV strongly recommends a physical completed before the start of Kindergarten or TK to ensure your child has every advantage to succeed in school. If your child has a medical condition that affects their ability to learn or daily life at school, please see nurse Karina for other documentation or forms that your doctor can fill out.
