Dave Pfaffle shared a report on a new math curriculum for the district, Illustrative Mathematics Curriculum.

Motion by De Jong, supported by Kleinhesselink to approve the adoption of the Illustrative Mathematics Curriculum for K-12, starting with K-5 during the 2022-23 school year and 6-12 during the 2023-24 school year. Motion carried unanimously.

The first reading of Board Policies 802.1-802.7 was presented.

Motion by Kleinhesselink, supported by Koerselman to approve the issuance of bid documents for the High School Entrance Addition and Renovation. Motion carried unanimously.

Motion was made by Kleinhesselink and supported by Koerselman to approve Board Policy Title: School Calendar, Code No. 601.2 for the 2022-23 school year. School will begin on August 23 and end on May 23 for a total of 180 classroom days and 191 contract days. The calendar is based upon the 1,080 hours of instruction method with the understanding that any full days missed will be made up. Commencement date to be determined after survey results are in. Motion carried unanimously. See attachment.

Motion by Koerselman, supported by De Jong to approve the resolution to authorize the public hearing for the proposed sale for the 2018 walk-in cooler from the high school. Motion carried unanimously.

Motion by Kleinhesselink and supported by De Jong to approve the engagement with Ahlers & Cooney P.C. as the bond counsel and disclosure counsel for the issuance for General Obligation School Bonds, Series 2022. Motion carried unanimously.

At 8:48 p.m., motion was made by Kleinhesselink and supported by Koerselman to enter closed session as provided by Chapter 21.5(1)(e) of the open meetings law to discuss whether to conduct hearings to suspend or expel a student, unless an open session is requested by the student or a parent or guardian of the student if the student is a minor.
