Superintendent Adams presented the preliminary budget for the 2015-16 fiscal year. State Supplemental Aid for next year has not been set, so the published budget will be set at 4%. If the State sets the State Supplemental Aid before the budget it published, the budget will be published at the rate set by the State. The proposed tax levies are as follows:

The instructional support levy is based upon ten per cent of the regular program cost with a rate of five per cent income surtax. The public budget hearing will be held on April 13, 2015, at 5:00 p.m. The notice of proposed budget will be published in the March 26 issue of the Sioux County Capital-Democrat.

Superintendent Adams gave the board a building project update.

The first reading of Board Policies 408.9-409.3 and 504.16 were presented. Motion by Jager and supported by Kleinhesselink to waive the second reading and approve the revisions of 504.16.

Motion was made by Kleinhesselink and supported by Jager to approve the PPEL budget for approximately \$123,325 for the 2015-16 fiscal year. Motion carried unanimously.

Motion was made by Jager and supported by Kleinhesselink to approve the following Budget Adjustment (Guarantee) Resolution:

RESOLVED, that the Board of Directors of MOC-Floyd Valley Community School District, will levy property tax for fiscal year 2015-2016 for the regular program budget adjustment as allowed under section 257.14, <u>Code of Iowa</u>.

Discussion was held on the bank bids for depository funds. It was decided to table this to receive more information until the next board meeting.

Discussion was held on the bid from Hoogendoorn Construction for the Athletic Complex Project. It was decided to table this to determine if possible adjustments can be made and will make a decision at a special board meeting held later this month.

At 8:10 p.m., motion was made by Kleinhesselink and supported by Jager to enter closed session as provided by Chapter 20.17(3) of the open meetings law for a negotiations strategy session. Van Roekel–aye, Jager-aye, and Kleinhesselink-aye.
