Motion was made by Kleinhesselink and supported by Immeker to adopt the board resolution regarding the Patient Protection and Affordable Care Act. Motion carried unanimously.

Bids were received for window replacement at Hospers Elementary and the High School from Vogel Paint and Glass for \$30,750 and Home Improvers for \$41,495. Motion by Kleinhesselink, supported by Jager to accept the bid from Vogel Paint and Glass for window replacement for \$30,750. Motion carried unanimously.

Motion by Jager and supported by Immeker to approve the transportation agreement with Mid-Sioux Opportunity Head Start for the 2016-17 school year. Motion carried unanimously.

A plan was presented to the board to consider air conditioning units at both of the elementary buildings. It was recommended that window air conditioning units be put in at Orange City Elementary and mini-splits be put in at Hospers Elementary as well as the High School. Motion was
