

MOC-FLOYD VALLEY COMMUNITY SCHOOLS - - - - May 8, 2017

The MOC-Floyd Valley Board of Education met on the above date at the Central Administration Office for its regular monthly meeting with all board members in attendance. Also present were Superintendent Adams, Secretary Dykstra, and the press.

President Van Roekel called the meeting to order at 5:01 p.m.

A roofing bid for the high school was received from Four Way Contracting for \$104,679. This was the only roofing bid received. Motion was made by Immecker and supported by

Kleinhesselink to accept the bid from Four Way Contracting in the amount of \$104,679. Motion carried unanimously.

Bids for copiers and printers for the district were received from Marco for \$35,192, Office Systems for \$38,337, and Century Business Products for \$40,930. Motion by Kleinhesselink, supported by Koerselman to accept the bid from Century Business Products for \$40,930. Motion carried unanimously. The reasoning for accepting the Century Business Products bid was because of the good service the district has received in the past and this would allow the district to have all of the leases and service contracts with one company.

A concrete quote was received for paving areas at the middle school and high school from Jellema Construction for \$37,636. This was the only concrete quote received. Motion was made by Kleinhesselink and supported by Koerselman to accept the concrete quote from Jellema Construction for \$37,636. Motion carried unanimously.
