An update was given on the district's future facilities plans. The time was set for a special meeting to hear the presentations from potential fiscal agents on March 19, 2019, at 5:30 p.m.

The first reading of Board Policies 204.14-204.19 was presented.

Motion by Reyes, supported by Koerselman to approve the 2020 Vocal Music trip to Minneapolis and the itinerary. Motion carried unanimously.

Motion by Reyes and supported by Koerselman to approve the changes made to the 2018-19 school calendar due to snow days. By changing the March 8 & 22, April 12, and May 10 early dismissals to full days, that will make up 2 snow days. This would make the last scheduled day of school May 29. Motion carried unanimously.

Motion by Koerselman, supported by Reyes to approve publishing the public hearing for use of the Flexibility Fund. Notice of public hearing will be published in the March 21 issue of the Sioux County Capital-Democrat. Motion carried unanimously.

Superintendent Adams presented the preliminary budget for the 2019-20 fiscal year. State Supplemental Aid for next year has been set at 2.06%. The proposed tax levies are as follows:

The instructional support levy is based upon 10% of the regular program cost with a rate of 3% income surtax. The public budget hearing will be held on April 8, 2019, at 5:00 p.m. The notice of proposed budget will be published in the March 21 issue of the Sioux County Capital-Democrat. Motion by Koerselman, supported by Reyes to approve the preliminary budget for the 2019-20 fiscal year. Motion carried unanimously.

Motion was made by Reyes, supported by Koerselman and carried unanimously to approve the following Budget Adjustment (Guarantee) Resolution:

RESOLVED, that the Board of Directors of MOC-Floyd Valley Community School District, will levy property tax for fiscal year 2019-2020 for the regular program budget adjustment as allowed under section 257.14, <u>Code of Iowa</u>.

Motion was made by Koerselman and supported by Reyes to approve the PPEL/SAVE for the 2019-20 fiscal year. Motion carried unanimously.

Motion made by Koerselman and supported by Reyes to approve the listing of certified staff members and their FTE, non-certified staff, and administrative staff. Once negotiations have been completed, contracts and work agreements will be sent. Motion carried unanimously.

Motion was made by Reyes and supported by Koerselman to approve publishing an ad for architectural/engineering services for the potential building project. Motion carried unanimously.

At 7:25 p.m., motion was made by Koerselman and supported by Reyes to enter closed session as provided by Chapter 20.17(3) of the open meetings law for a negotiations strategy session. Jager-aye, Koerselman-aye and Reyes-aye.

The meeting reconvened in regular session at 8:32 p.m. and immediately adjourned.
